Average balance to waive fee ..... \$5,000.00  
First 50 cleared checks ..... FREE  
51 to 100 ..... \$0.15 per item  
101+ ..... \$0.25 per item

NSF Return Fee ..... \$27.00 per presentment  
May be charged a fee each time item is submitted or resubmitted for payment  
Not sufficient fund returns for Checks and/or ACH

Overdrawn Fee ..... \$27.00 per item  
Negative balance due to ATM/POS

Savings to Business Checking Transfer ..... \$10.00 per transfer  
Overdraft transfer for payment of checks, debit card transactions, ACH, and  
debits by other electronic means
